FAMILY READINESS - READY FOR DEPLOYMENT

As a Reserve Component (RC) (Army Reserve or National Guard) A Soldier is ALWAYS to be Mission Ready.

Which means the Service Member (SM) Family needs to be ready as well.

WHO ARE IMMEDIATE FAMILY MEMBERS:

The immediate family includes the following family members of either the <u>Soldier or the Soldier's spouse</u>:

- (1) Parents, including stepparents.
- (2) Spouse.
- (3) Children, including stepchildren.
- (4) Sisters, including stepsisters.
- (5) Brothers, including stepbrothers.
- (6) Only living blood relative.
- (7) A person in loco parentis.





WHO ARE IMMEDIATE FAMILY MEMBERS:

• (7) A person in loco parentis. A person in loco parentis is one who stood in place of a parent to the soldier or the soldier's spouse for 24 hours a day, for at least a 5-year period before the soldier or the soldier's spouse became 21 years of age. The person must have provided a home, food, clothing, medical care, and other necessities as well as furnished moral and disciplinary guidance and affection.





WHO ARE IMMEDIATE FAMILY MEMBERS:

 A GRANDPARENT, or other person, normally is not considered to have stood in place of a person when the parent also lived at the same residence. A person is not considered in loco parentis for performing baby-sitting or providing day care services.





WHAT DO I NEED TO BE "READY"

- A Copy of the Soldiers Orders
- Know the Soldiers Social security Number (Also on the Orders)
- Know the Unit Identification (Also on the Orders, IF deployed –
 if not deployed WHERE are they drilling?)
- Where is the Soldier Located (Home of Record during Drilling status, or STATE or Country Deployed to)
- What is the Emergency to be verified?
- American Red Cross Number: 877-272-7337
- FRG Contact person





WHAT DO I NEED TO BE "READY"

THE AMERICAN RED CROSS WILL NEED THE FOLLOWING INFORMATION:

Service member's:

- Full name DANIEL SMITHLING
- Rank/rating SPECIALIST
- Branch of service (Army-overseas, NATIONAL GUARD = home station)
- Social Security Number123-45-6789 or Date of Birth Oct 10, 1987
- Military address APO AE XXXXX overseas / OR ARMORY
- Information about the deployed unit and home base unit (for deployed service members only) 508TH MPCSC(NJ GUARD)
- Information regarding the Emergency, Hospital, Physicians, Funeral Director, Contact person, phone number, Fax number, etc





When a military family experiences a crisis, the American Red Cross is there to help. Twenty-four hours a day, 365 days a year, the Red Cross relays urgent messages containing accurate, factual, complete and verified descriptions of the emergency to service members stationed anywhere in the world, including on ships at sea and at embassies and remote locations.

Once the Family Member provides the American Red Cross (ARC) with the necessary information, the Family Member will be assigned, by the ARC a **CASE Number** – write it down.

The ARC Contacts the Commander (Home Station or Overseas) the Ultimate decision to call back a Soldier home is the Commanders decision.





Family emergencies requiring the presence of a military service member begin back home with the death/serious illness of a family member. Once the local Red Cross has verified all details relating to the emergency, information is sent to the service member who may be stationed anywhere worldwide. The family may want this information shared with military commands who will decide if the service member should be granted emergency leave to come home. Commands frequently require Red Cross verification before emergency leave is granted.





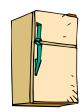
Military leaders rely on the American Red Cross to provide objective, timely, confidential, factual, complete, and verified information on emergency family situations. Without this verification, the service member may not be able to come home during a family crisis.



WHERE DO I KEEP THE DOCUMENTS:

Family Members may consider keeping a copy of their Service members ORDERS, the ARC phone number, FRG Contact information, FAC contact, Rear Detachment (if deployed)

- (1) Copy on the refrigerator (with your FRG contact list)
- (2) Copy in your vehicle's glove compartment
- (3) Copy in your purse or attaché case
- (4) With a neighbor / or family relative/ and at your Work location







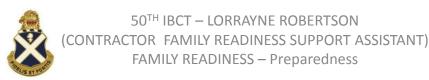






WHAT IS CONSIDERED AN EMERGENCY

Red Cross emergency communications services keep military personnel in touch with their families following the death or serious illness of an immediate family member, the birth of a service member's child or grandchild or when a family faces other emergencies (Floods, earthquakes, tornados,)





WHEN DO I PREPARE:

As a Reserve Component (RC) (Army Reserve or National Guard) A Soldier is ALWAYS to be Mission Ready. Which means the Service Member (SM) Family needs to be ready as well.

Guard Soldiers are always ready and always there.

Do NOT wait for an emergency to prepare, Do it NOW while thinking is clear. Guard Families need to be Ready 24/7.

ARMY / NG REGULATIONS:
